New Rule Passed

Part III Rule 9C was amended to read:

"In addition to the contestant, there must be a crew consisting of not less than two, nor more than four persons."

Part III Rule 9C previously read:

"In addition to the contestant, there must be a crew consisting of not less than two, nor more than three persons."

The additional person will accommodate those teams with less than ideal physical abilities, younger or elderly persons, lighter teams, teams that want to sail with a "ride-along", and those teams that normally sail with five at the local level.
